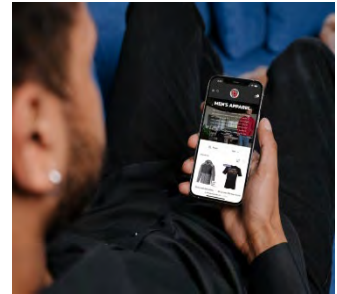



Sunburst Corvette Club Charities for 2023

CASA of McHenry County - Becky Morris, casamchenrycounty.org

CASA stands for: Court Appointed Special Advocates for Children. Their mission is: To support and protect children who have been abused or neglected by providing them with trained, committed volunteers who advocate for their best interest. Here is additional information from their website:

Every Child Deserves to Live in a Safe, Loving, Forever Home.

Every day, abused and neglected children in our community are placed into temporary foster care because their parents cannot - or will not - take care of them. Court Appointed Special Advocates (CASA) of McHenry County **gives these children a voice** in court so they can grow up in safe, forever homes where they can thrive.

PAWS for Pure water - Patti Schulz <http://www.pawsforpurewater.org>

PAWS consists of a small group of women (and is a 501, c3) whose mission is to make and sell mittens, which in turn funds wells in Africa. The wells are in the center of the community and often affect more than 1500 people's lives. To date they have funded 17 wells, which cost \$7,500 each and that is an average sale of 200 mittens/well. That is over 3,400 mittens and \$127,500.00 in the last 8 years. All of the mittens are handmade using recycled wool and cashmere sweaters that have been donated or purchased at resale stores. They have been washed and felted, cut and sewn, matched with fleece lining for warmth and comfort, tagged and sold at home parties, through word of mouth, at events, in the retail store: Kitchen Outfitters in Crystal Lake, and through their website.

Salvation Army - Lieutenant Nancy Rivera

The Salvation Army is an integral part of the Christian Church, although distinctive in government and practice. The Army's doctrine follows the mainstream of Christian belief and its articles of faith emphasize God's saving purposes.
